Who we are

Southern Community Justice Centre is a community legal centre that provides a free initial consultation with a solicitor to most members of the community regardless of their level of income and assets. When you consult with our Service at this first stage of assistance, we cover most areas of law.

What does the centre do?

The service provides:

- Information and referral
- Legal advice
- Ongoing assistance and court representation, where appropriate, are provided at no cost to eligible clients who cannot afford to pay a private solicitor and do not qualify for a grant of legal aid.
